Terms & Conditions

Hartford Chorale Participant Agreement

Hartford Chorale acts only as the trip organizer or “Sponsor”, and is not responsible for the acts or omissions of other parties. The trip described in your itinerary (the “Tour”) may include services provided by one or more independent operators or service providers (each, a “Supplier”). Hartford Chorale may be referred to herein as “we” or “us.” Each traveler registered for the Tour is referred to herein as a “Participant”. Any Participant under the age of 18 MUST be accompanied by a parent or guardian. Such parent or guardian assumes full responsibility for Participant under the age of 18 and agrees to indemnify and hold Hartford Chorale harmless from and against any costs, damages, losses or liabilities arising out of the actions or omissions of any Participant under the age of 18 traveling with parent or guardian. The terms and conditions of this Participant Agreement apply to your Tour and the program for the Tour (the “Itinerary”).

Pricing and Inclusions

Prices include programming, planning, handling and operational charges and are based on current rates of exchange, airfare and fuel surcharges, tariffs and taxes in effect at the time of publication. We reserve the right to increase Tour prices to cover increased costs, tariffs, and taxes received after prices are published and to reflect fluctuations in foreign exchange markets. We will notify you of any such additional costs as soon as practicable after we become aware of them.

Exclusions

Quoted Tour prices exclude: trip insurance; transportation to and from the US airport; baggage fees, including excess baggage charges, charged by airlines; ground transportation other than by passenger motor coach in UK; costs associated with obtaining passports or entry visas; airport departure taxes (unless otherwise noted); any travel deviations not specified in the itinerary; meals and beverages other than those specified in the Itinerary; sightseeing not included in the Itinerary; personal expenses.

Reservations and Payments

The Initial Deposit amount required for the Tour is listed on your registration form. The Initial Deposit is required in order to confirm your booking and is nonrefundable. Payment can be made via check or credit card payable to Hartford Chorale Tour. Upon receipt of the deposit, we will send you confirmation of your booking. The installment payments will be due on the dates specified in ACFEA Tour Central and must be paid via ACFEA tour central. If a Tour is already full, we may accept deposits on a standby basis. If space becomes available, you will have the choice of joining the Tour by paying in full at time of registration.

Travel Protection Insurance

Travel protection insurance is highly recommended. This insurance helps protect your investment in the event you must cancel the Tour and could also provide certain medical coverage while you are outside of the United States. Insurance applications are available upon request, or you may pursue your own carrier. Any questions about the terms of your coverage, what travel insurance does or does not cover should be addressed directly to the travel insurance company. Cancel for any reason coverage should be considered because we strongly adhere to the cancellation policy. If you decline insurance coverage, you will personally assume full responsibility for any financial loss associated with your travel arrangements, and you could lose your travel investment and/or have to pay more money to correct the situation.

Cancellation by You

Your decision not to participate on the Tour due to State Department warnings, fear of travel, illness or any other reason will be deemed a cancellation. If a flight or other delay for any reason prevents you from joining the Tour on the Tour departure date and time, you will be considered a no-show, and we cannot provide a refund; however, you may join the Tour late if agreed to in writing by us.

Air Transportation during the Tour

Airfare costs and availability are subject to change at any time prior to final payment for your Tour and may result in an increase in the Tour price or a modification of the itinerary. We will notify you of any such change as soon as practical. Airlines often change seat assignments to satisfy their loyalty members or because of equipment changes (aircraft type). We are not notified of these changes in advance, and often travelers are not made aware of these changes until they arrive at the airport. We cannot be responsible for seat assignment changes made by the airline. Frequent flier programs are private agreements between airlines and passengers, and we cannot be held responsible for mileage discrepancies involving airline loyalty reward programs. Each participant is responsible for complying with all applicable airline requirements, including baggage requirements and hazardous materials prohibition.

Passports and Visas

You are solely responsible for complying with passport and visa requirements as applicable. International travel requires a passport valid six (6) months plus one day beyond your intended return travel date and **must contain at least one blank page**. Please apply for your passport immediately due to the amount of time it may take to process your passport application. You must have your passport in your possession at all times while on your Tour. **You must also provide us with a copy of the inside page of your passport (showing your name and photo) at the time of reservation and in no event less than 90 days prior to departure.**

Cancellation or Substitution by Us

We will make commercially reasonable efforts to keep the Itinerary as it has been published; however, the final Itinerary may vary due to availability and factors beyond our control. We may in our sole discretion substitute services such as hotels or goods of similar quality for any service or good stated in the Itinerary.

Baggage

Please refer to your final travel documents for information and links to determine the total baggage fees charged and specifications and limitations imposed by your airline or motor coach. Checked baggage is limited to **one** checked bag per person and one carry-on bag that will fit under an airline seat and/or on the small parcel racks of the motor coach. There can be no exceptions to this limitation. You are responsible for complying with the weight and size limitations imposed by airlines. Please confirm all specifications when you receive your final travel documents, as they can and do change from time to time. We assume no liability for loss or damage to baggage in transit to and from a Tour or while on a Tour. We recommend purchasing a supplemental travel insurance package.

Photography and Video

We may take photographs or videos of Tours, Tour Participants and/or performances, including live webcasting of performances from time to time, and Participant grants us express permission to do so and to use such photographs or videos for promotional or commercial use without payment or any fee or royalties payable by Hartford Chorale to Participant.

Tour Singers

All singing participants will receive appropriate scores for musical performances. Singers are expected to prepare in advance by learning their part, marking scores utilizing edit masters provided on the Chorale website and attend all rehearsals. Singers must provide black score covers and adhere to performance dress code while on tour.

Conduct During the Tour

You are responsible for respecting the authority and following the directions of the Tour staff and the laws of the countries in your Itinerary during a Tour. We may exclude you from participating in all or any part of the Tour if, in our sole discretion, your condition or behavior renders you unfit for the Tour or unfit for continuation once the Tour has begun. Unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of Tour services or may constitute a hazard or embarrassment. In such case, no refunds will be made for those unused parts of the tour. Should you decide for any reason not to participate in certain parts of the Tour or use certain goods included in the Tour, no refunds will be made for those unused parts of the Tour or goods. You agree to indemnify and hold us harmless from and against any costs, damages, losses or liabilities arising out of the actions or omissions of any minors traveling with you.

Release and Hold Harmless

Participant, on behalf of Participant, Participant heirs, executors, administrators, agents, attorneys, representatives, successors, assigns, and any person subrogated to Participant rights, having any rights of representation by or through Participant, and/or claiming through Participant, hereby covenant not to sue, release, acquit and forever discharge and hold harmless the Sponsors, including, without limitation, all of their present, former, and future officers, board members, members, employees, attorneys and assigns, of and from: Any and all past, present or future claims, actions, causes of action, rights, damages, costs, losses, expenses, judgments, demands, obligations, interest and compensation, of every kind and nature whatsoever, known or unknown, foreseen or unforeseen, in law or in equity, attorney's fees and costs, arising out of, involving or relating to the Tour, including, but not limited to (1) breach of contract, negligence, errors or omissions on the part of the travel agent or other suppliers of travel-related services in connection with the Tour; (2) claims arising out of or relating to criminal acts, terrorism, strikes, travel delays, lost luggage, mechanical or construction failures, weather, misinformation, local laws, health conditions, or any other circumstances outside of the Sponsors' exclusive control.

Assumption of Risk

Participant assumes the risks and responsibilities of travel, including the responsibility to obtain the required passport, visa, vaccination and entry requirements. Participant understands that the Sponsors recommend obtaining optional travel insurance.

Governing Law and Forum Selection

Interpretation of the terms and conditions of this agreement are to be construed according to the laws of the State of Connecticut. Any action regarding the terms of this agreement or the matters addressed herein must be brought in the state or federal courts of Connecticut.

General

Our receipt of a facsimile or scanned transmission of any signed document shall be deemed delivery of an original. We reserve the right to decline to do business with anyone on a nondiscriminatory basis.
